4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The graduate is employed in the middle management positions in the field of viticulture, wine and fruit growing and related gardening areas in work activities related to the reproduction of garden nursery material cultivation of vines and fruit trees, wine production, eventually storage and processing of fruits. He/she can also work in specialized shops and in the field of agri-tourism.

Examples of possible job positions: vineyard and pomiculture technician, cellarman for wine production, a worker in business services, sommelier, entrepreneur in the field of viticulture and fruit growing services, employee of land and cadastral offices, etc.
